Actions Taken Outside a Meeting:

- The board ratified the following:

Concrete Fence-City of Pearland approved our permit and construction should begin Tuesday, May 28, 2019, weather permitting.

Pool fence-has been installed. Temporary chain link fence is placed along back until the concrete fence is in place.

# MANAGEMENT REPORT

- The board reviewed proposals for power washing and unanimously approved the McKenna proposal for \$3,425.00. Mr. Glazier advised that some of the monuments have loose stones. Management will advise McKenna and also get proposals for repair.
- The board reviewed proposals from Interior Green for holiday decorations. Two options and a storage proposal were submitted. The board voted 5-1 to approve Option 2 and the storage proposal. Mr. Boyer was opposed.
- Texas Fence proposal-The board reviewed the proposal to add fencing to the open area off of West Oaks Circle. Management will confirm these are cedar pickets. Management will get 2 additional proposals.
- The board agreed to find a new venue for the annual meeting.
- Management is coordinating moving the 911 phone from the outside to the inside of the pool.
- Encroachment letters were sent to homeowners on English Oaks and Old Oaks Boulevard for fencing in HOA property. After reviewing the survey for English Oaks, the board agreed that this letter was sent in error. Management will contact the homeowner and advise.
- An offer from Enterprise pipeline was reviewed and discussed. Mr. Rathbun will get additional information on the value of the easement property and the board will determine if and/or what the counter offer will be.

# HOMEOWNERS FORUM

Mr. Melgoza advised that the back fencelines of Keithwood off of Fite are still not being mowed by Texas Erosion. Management will speak with Texas Erosion and ask Western to clean it up in the interim.
